Get Your Mitts on Some Cash Debit Card Drawing
Official Rules

1. How to enter: Entrants must be 18 years or older. Eligible participants automatically receive one entry for each ServU Visa Debit Card qualified transaction that posts and settles December 1 – 31, 2017. A qualified transaction is a "credit transaction" processed at an eligible merchant. Transactions may not necessarily post the same day as the debit card purchase. No purchase necessary to enter or to win. Void where prohibited. Mail entries are accepted. To enter: mail a 3"x5" index card with the entrant's name, address, phone number and email address to:

Limit one entry per envelope. Cut off time for receipt of all entries is December 29, 2017 at 5:30 PM.

2. By participating, all entrants agree to abide by these Official Rules and the decisions of ServU, which are final and binding in all respects.

3. Employees, officers and directors of ServU, as well as the immediate families (spouse, parents, children and siblings, regardless of residence) and household members of such employees, officers or directors (whether related or not), are not eligible to participate in the Drawing.

4. One daily prize winner will be randomly selected each weekday from December 4, 2017 through January 2, 2018. Monthly prize winners will be randomly selected from all eligible entries on January 2, 2018. Odds of winning depend upon the number of eligible entrants. Selected winners will be notified by phone and/or by mail – Sponsor will select the method of contact. Sponsor not responsible for lost, late, or misdirected mail or any problems in contacting entrant by telephone, including but not limited to incorrect or out-of-date contact information on file with Sponsor.
