

## **ServU Federal Credit Union Owlstanding Teacher Award Official Prize Contest Rules**

1.) How to enter: Anyone may nominate a K-12 teacher who works in Steuben, Chemung, Yates, Allegany or Schuyler counties. Nominees must be aged 18 and above. Nomination forms can be obtained at any ServU Federal Credit Union location. Completed nomination forms can be returned in person to any ServU Federal Credit Union location or by mailing to:

No purchase necessary to enter or to win. Void where prohibited. Limit one entry per person per day. Cut off time for receipt of all entries is April 27<sup>th</sup>, 2018 at 5:30 PM, including entries by mail.

2. By participating, all entrants agree to abide by these Official Rules and the decisions of ServU, which are final and binding in all respects.

3. Employees, officers and directors of ServU, as well as the immediate families (spouse, parents, children and siblings, regardless of residence) and household members of such employees, officers or directors (whether related or not), are not eligible to participate in the Contest.

4. Winners will be selected from among all eligible nominees based on the following criteria: Demonstration of the characteristics that exemplify the credit union philosophy of "people helping people" including: Commitment to Students – 50% Innovative Teaching Style – 25% Concern for the Community – 25%. Judging will be conducted April 30 through May 2, 2018 by a committee of ServU employees. Selected winners will be notified at their employing school. Sponsor not responsible for lost, late, or misdirected mail or any problems in contacting winner by telephone, including but not limited to incorrect or out-of-date contact information on file with Sponsor.

Selected winners will be required to sign and return an Affidavit of Eligibility and Release within 14 days of its receipt. Prize may be forfeited and awarded to an alternate winner if (1) any affidavit or release is not returned within the stated time frame, (2) prize notification is returned as undeliverable, or (3) prize cannot be awarded to selected winner for any reason.

5. By participating in the Contest and/or accepting the prize, all entrants and winners consent to the use of their name, photograph, likeness, voice and/or video for advertising and promotional purposes, including online announcements without limitation and without additional compensation, except where prohibited by law.

6. PRIZES: (3) \$100 cash prizes. One per winning nominee. No substitution or transfer of prizes by Winners is permitted. If a specified prize becomes unavailable due to unforeseen circumstances, Sponsor may substitute a prize of like or equal value. No prizes will be awarded to the nominator.
